#### **Research Interests**

Broadly speaking my research explores the various ways in which housing (i.e., the subjective appraisal of the lived environment) matters to the health and well-being of African American adolescents and emerging adults. This research agenda seeks to advance knowledge on the positive and negative effects of living in urban public housing developments on the psychological functioning, health-risk behaviors and physical health of African American adolescents and emerging adults who lives in these communities. This research also seeks to inform practice by assessing how, or whether, various protective factors such as self-efficacy, parental monitoring, civic participation and community cohesion are directly and indirectly related to adolescents' health and wellbeing.

In addition to my work in public housing, I am interested in the various paths that incarcerated parents with dependent children must take as they attempt to reenter society and resume their role as parents. Specifically, this research seeks to advance knowledge on how a state's policy position on whether to ban or not to ban individuals convicted of a felony drug charge from receiving public assistance (i.e., SNAP, TANF & Public Housing) is related to health-risk behaviors, sex-risk behaviors and food insecurity in the parent returning home and her dependent children.
