Anchoring Health Equity: A Community-Based Cardiovascular Care Initiative at Morgan State University

Morgan State University, as Baltimore's premier public urban research institution, is committed to advancing Strategic Goal 5: Serve as the Anchor Institution in Baltimore. This proposal seeks \$10,000 in support of a community-driven, interdisciplinary intervention that addresses cardiovascular disease (CVD) disparities among African Americans in Baltimore City.

Leveraging the combined expertise of Social Work and Public Health, the project will implement a culturally tailored, social work-led and supported model that integrates health education, patient navigation, community health worker engagement, and telehealth access. The initiative emphasize holistic support, addressing both clinical care and social determinants of health while promoting advanced care planning in underserved communities. Expected outcomes include improved health literacy, increased advance directive completion, reductions in preventable hospitalizations, and enhanced quality of life. This initiative aligns with Morgan State's anchor mission by embedding research, education, and service into the local community, strengthening trust, and fostering sustainable partnerships. Funding will be used for workforce training, culturally relevant materials, telehealth infrastructure, community engagement, and evaluation. The proposed project exemplifies Morgan State's leadership role in Baltimore as a transformative anchor institution addressing systemic inequities in health and advancing community well-being.

Evaluation efforts will focus on measuring the impact of navigator support on placement outcomes and family well-being.

This initiative recognizes the unique needs of kinship families and seeks to strengthen their capacity through targeted education and support. By enhancing the competency of Kinship Care Navigators, the program aims to improve the overall quality of care for children living with relatives. Additionally, the findings from this evaluation will inform future program development and policy recommendations at the local and state levels.
