The College enrolled over 1800 students (over 1500 undergraduate and over 200 graduate students) and included approximately 100 faculty members (47 full-time) and 10 staff persons. As the Chief Administrative Officer, I was responsible for managing and maintaining the academic and fiscal affairs, integrity, and effectiveness of the College of Professional Studies, which had an annual operating budget of over 6 million dollars. I provided leadership in shaping the College's vision and mission and in implementing the delivery of its educational services. I also established and maintained community partnerships and external relations.

A few major accomplishments of the College of Professional Studies during my five years as Dean were as follows: 1) the College generated almost \$4 million in extramural funding, and the scholarly productivity of the faculty significantly increased; 2) the College maintained high enrollment, retention, and graduation numbers; 3) the Master of Science in Nursing (MSN) program received full reaffirmation by the Accreditation Commission for Education in Nursing; 4) successful outcomes were achieved for the periodic academic review of programs required by the Maryland Higher Education Commission; and 5) global learning opportunities in Cuba, Germany, South Africa, and Japan were established.

As professor, I taught across programs, but primarily in the master's program, and served on dissertation committees. My primary teaching areas were research methods, cultural diversity, and oppression studies.
