Procedures to apply for Summer Session(s) Aid

1. Retrieve a summer application from the following link:
http://www.morgan.edu/financial_aid/required_forms.html
2. Applications will only be processed if students are registered for summer classes.
3. Submit the completed application to the Office of Financial Aid (OFA), Montebello RM A203.
4. Allow 2-4 weeks for Financial Advisors to determine your aid eligibility and to process your award. Your award will be posted on Websis at: www.morgan.edu. Find financial aid offers and accept or decline your loan award **immediately**. All grants and scholarships are automatically accepted.
5. Aid will consist of residual aid that was not awarded during Fall or Spring semesters for the current academic year.
6. Residual aid could consist of federal aid i.e. Pell Grant, Subsidized and Unsubsidized Loans, parent Plus loans or private Alternative loans. More information regarding federal aid types can be found at:

7. If the school determines that you are not eligible to receive residual/additional financial aid, OFA will notify you via your MSU email address.
8. If parents are applying for the Direct Plus loans or students are applying for the private Alternative loans, please apply early using the summer sessions as the loan period at: www.studentloans.gov.
