

Legal Consultation Services

Finding appropriate legal services is easy with BHS. When you call BHS, a Care Coordinator will conduct a needs assessment to determine how we can best support your legal needs and provide you with an overview of the legal services and resources available.

What to Expect

Following your initial assessment the Care Coordinator will connect you with a legal representative that will more fully explore the legal aspects of your issue and provide an attorney referral if needed, that has availability within three to five business days, to provide a telephonic or face-to-face consultation for up to 30 minutes. Once you have completed your 30-minute consultation you will be offered a 25 percent discount off the attorney's hourly rates for ongoing services regarding the same issue. Your BHS Care Coordinator will provide on-going support and offer additional assistance, if needed, until your issue is resolved.

Note: BHS does not consult on work-related legal issues.

Recognize and Protect Against Identity Theft

Identity theft happens when someone uses your social security number or other personal information to open new accounts, make purchases or get a tax refund. But identity theft can have ramifications beyond financial harm: you may be denied access to crucial services, medical care and even employment. Our Identity (ID) Theft Program assists you with understanding the risks you face and best practices to protect your personal information. If the worst occurs, we work with you to help recover from incidents of identity theft.

Specially trained coaches provide guidance and explain the differences between a data breach and the nine most common types of identity theft (social security, driver's license, financial identity, criminal identity theft, insurance, medical, tax, child and synthetic identity theft). Our coaches will also guide you through the different types of scams that can result in ID theft, such as phishing and skimming scams, and how you can best protect your personal information.

Additionally, an ID Theft Resource Guide developed by our financial coaching team is available. This guide includes tips on identifying the type of identity theft, first steps you can take if you are a victim of identity theft and the many free credit monitoring options available.

A Recovery Guide is also available for those recovering from identity theft that contains step by step protection and recovery options, including immediate steps, next steps and form letters, as well as a system for monitoring the recovery progress.
